Chairman Johnson called the meeting to order at 9:00 a.m.

CONSENT ITEMS

Chairman Johnson opened the matter up for Public and Commissioner Comments.

No comments were made.

A motion was made by Commissioner Villapudua and seconded by Commissioner Patti to approve the Consent Calendar.

The motion for approval of the Summary Minutes of March 14, 2019, was passed by an unanimous vote of the Commission.

The motion for approval for the out-of-agency service request to the properties located at 3527 Utah Avenue, 3559 Mourfield Avenue, 2516 S. B. Street, and 2502 S. B Street, Stockton, was passed by a unanimous vote of the Commission.

PUBLIC HEARING ITEMS

 FIRE SERVICES GOVERNANCE MODEL FOR THE CITY OF TRACY AND THE TRACY RURAL FIRE PROTECTION DISTRICT (Action by Regular Members) The Commission to consider a policy regarding detachment from the Tracy Rural Fire Protection District.

James E. Glaser, Executive Officer, provided a historical overview on the issue before the Commission and provided justification for his recommendation that the Commission adopt a policy of detachment of the Tracy Rural Fire Protection District when territory annexes into the City Tracy. The issue of a fire service governance model has been pending since October 2011 when the Commission adopted the Rural Fire District Municipal Service Review which included an Implementation Strategy that states: "Complete a plan regarding the governance model for Tracy City Fire Department and Tracy Rural FPD within 18 months subject to the approval of LAFCo. All subsequent annexation requests shall be consistent with the approved plan." Mr. Glaser stated that the City had prepared at least three studies to address the Commission's concerns regarding the governance model to provide fire services but the studies fell short in properly analyzing all governance models requested by the Commission, did not come with a recommendation from the City and Tracy Rural, or contained incorrect financial data. Mr. Glaser stated that the current "no detachment" policy conflicts with the Cortese Knox Hertzberg Act as well as the Commission's own policies for annexation. He stressed the importance of the Commission in making public policy and that whatever policy decision made today will have lasting financial implications. He stated that the 12 annexations approved with no detachment will not be affected by today's action. Mr. Glaser referred the Commission to the written comments provided by the County Administrator's Office. The CAO obtained financial data from the County Auditor's Office showing the financial loss to the County in the amount of \$74M from 2001 to 2026 during which time the 12 annexations were not detached from Tracy Rural. The CAO recommended that the City of Tracy follow the policy that occurs in other County cities of Stockton, Lodi, and Manteca, and detach territory from the rural fire district upon annexation.

Chairman Johnson opened the floor for Commissioner Comments.

Commissioner Patti requested clarification on what was included in the \$74M projected loss for the County and whether any action taken by the Commission today will affect this loss of funds.

Mo Hatef, Senior Deputy Administrator, San Joaquin County and Stanley Lawrence, Chief Deputy Auditor-Controller, San Joaquin County, stated that the \$74 million loss includes the existing 12 annexations without detachment from 2001/2002 to 2026/2027 and any action today will not affect this amount of loss. The County is requesting that the Commission approve detachment from Tracy Rural Fire Protection District from future annexations.

Mo Hatef, Senior Deputy Administrator stated that the \$74M is based on a share of 11% of the property tax rate from the 12 annexations to the year 2026/2027.

Commissioner Winn stated that the City of Tracy benefits by no detachment but the City needs to take over fire services.

Chairman Johnson closed the floor for Commissioner Comments.

Chairman Johnson opened the floor for Public Comments.

Karen Schneider, Finance Director for the City of Tracy, represented both the City of Tracy and the Tracy Rural Fire Protection District under the Joint Powers Agreement and she worked on the negotiations. The fiscal analysis is based on this current model and stated that if the Commission changed the policy, it will change the City of Tracy's model which has been growing and getting stronger. Additionally, the City has received grants based on this model. Ms. Schneider stated that LAFCo is holding two annexations hostage over this governance issue. The City of Tracy is asking for two things from the Commission: to continue to move annexations forward and to postpone the policy of detachment while the City, Tracy Rural and the County work on this together.

Commissioner Kuehne stated that all cities that annex new development enter into a tax sharing agreement with the city to take over the services and that Tracy has failed to do that.

Karen Schneider, Finance Director City of Tracy, stated that the fiscal model has been able to support the current governance model and changing this model will cause fiscal harm to the fire services. She said that changing the policy will take away two their revenue sources of property taxes and assessments and that this is a decision that should be done between the County and the City, not LAFCo.

Commissioner Kuehne stated that LAFCo is responsible for both fiscal growth and development growth including the fiscal implication for the County as well. He stated that the decision needs to be completed before any annexations and to do otherwise would not be a good steward for this board. Although it is not an easy decision it needs to be based on LAFCo's responsibility.

Chairman Johnson stated that a comment was made about holding two annexations hostage. This policy has been in effect for 23 years and nothing has been done. Now that deadlines are approaching for these two annexations the City is asking to allow the annexation to go through while the City is working on agreement.

Commissioner Winn agreed with Chairman Johnson that the City of Tracy is asking for the matter to be continue when this practice that has been going on for almost 23 years. Mr. Winn said that a decision on policy needs to be made today.

Karen Schneider, Finance Director, City of Tracy, added that another reason for asking for a continuance is that the City does not agree with the Executive Officer's conclusions on the staff report and they have drafted a letter to be sent to him and the Commission outlining the concerns.

Chairman Johnson stated that this is why LAFCo is holding a special meeting and now is the time for discussion. The items should have been presented today.

Randall Bradley, Fire Chief with the City of Tracy, stated that he was brought in by the San Joaquin County Fire Authority to review their governance model. He stated that the model results in high service performance and the fire stations are now strategically located. He indicated that the County has received \$50M from these past developments.

Commissioner Kuehne commented that no one has denied the level of fire service for Tracy. Commission Kuehne asked for clarification on the loss of revenue of \$74M for the county and the

additional revenue due to non-annexing property and additional funds that the County has received.

Jay Wilverding, Auditor-Controller for San Joaquin County, stated that he did not have the numbers to correctly answer the question.

Chairman Johnson restated the question that the Fire Chief said that though the County will have a \$74M loss for not detaching, they have received \$50M generated from new development.

Commissioner Winn added that the revenue was from an increase in other taxes and not the 11% from the fire district.

Jay Wilverding, Auditor Controller for San Joaquin County, stated the tax rate areas get different shares. As cities grow the 18% or 19% that the County receives will grow as well. Regarding the tax sharing agreements with cities, the verbiage is all the same. Also depending on when the agreements were done will depend on the County/City split. Tracy is not treated any different than other Cities.

Robert Rickman, Mayor of City of Tracy, stated that he has spoken with different Mayors and City Council members regarding the tax sharing agreements and found that tax sharing agreement of 80%/20% is one of the worse in the State of California. He found that most other cities are 50%/50%. The City is looking to change that. He stated that the fire service for Tracy is by far one of the best, if not the best and it has received one of the few hazmat vehicles due to their model. Also, the tax sharing agreement is a concern is for all County cities. Mr. Rickman requested that the annexations go through the process and the City will work with the County on the tax sharing agreement.

Mark Bowman, Attorney for the Tracy Rural Fire Protection District, asked that before the Commission makes any policy change that the Commission has evidence that the provision of fire services will not be degraded by this detachment. Chief Bradley stated that the Joint Powers Agreement model provides the best service available.

Jeff Schroder, Ponderosa Homes, stated that he is one of the two annexation projects that is being delayed. He stated that there is a housing crisis resulting in a million dollars of loss to the County. This issue is a County and City issue and not a LAFCo issue.

Commissioner Patti asked the Executive Officer if an annexation with detachment will hold up an annexation.

James E. Glaser, Executive Officer, said it will not hold up an annexation and in fact may go faster.

Commissioner Morowit wanted clarification on the financial impact to the city or to the developer if this matter would continue to be delayed.

Jeff Schroder, Ponderosa Homes, stated that revenue is flat right now and costs are going up. He stated that if the only way to proceed is to detach from the Tracy Rural Fire Protection District then he will make that decision but that development is bringing new money into the County and improving the County's fiscal plan. He stated that the issue of detaching is a huge issue and it should be between the City and County and not a LAFCo issue.

Chairman Johnson stated that the growth of cities in regards to County land is a LAFCo issue and that the policy decided upon today will affect all future annexations and this matter should have been settled a long time ago and now is the time for this Commission to decide.

Justin Legasa, Tracy Firefighter and Paramedic representing Tracy Fire Union Local 3355, discussed the importance of the JPA agreement and the vast improvement it has done for the Tracy Rural Fire Protection District. He stated that requiring detachment would be detrimental to the service that would be provided to the residents.

Leticia Ramirez, Assistant City Attorney for the City of Tracy, stated that issue has been pending for 23 years and it should have been resolved but it has not. She asked if the City agrees to have the annexations detach from the Tracy Rural Fire Protection District can the City skip the Municipal Service Review (MSR) and the Sphere of Influence (SOI) Update to proceed with the annexations.

Mr. Glaser, Executive Officer, said that if the Commission sets the policy to have future annexations detach from the Tracy Rural Fire Protection District, then the annexation process could be done faster, however, the City of Tracy would still need to do a MSR and SOI Update.

Leticia Ramirez, Assistant City Attorney for the City of Tracy, restated that the City has additional information regarding this matter for the Commission to consider.

James E. Glaser, Executive Officer, stated that the Commission also has the option to continue this matter.

Chairman Johnson stated that he does not understand why the City of Tracy wants to wait on this matter. The City of Tracy has come before the Commission during the last few months wanting to get on the Commission Agenda and now that this special meeting is being held, they are not prepared.

Leticia Ramirez, Assistant City Attorney for the City of Tracy, stated that this is a financial issue that needs more time to have the concerns addressed and they would like to respond to the County letter dated April 15, 2019.

James E. Glaser, Executive Officer, stated that the recommendation to establish a LAFCo policy on detachment is not solely based on economics, but on LAFCo principal.

Commissioner Patti inquired about the policy of detaching and if it was consistent with other LAFCos.

Mr. James Glaser, Executive Officer, stated that the fundamental purpose of LAFCo is the determination of whether a district would detach or not detach and this decision rests solely with LAFCo.

Chairman Johnson asked Rod Attebery, Legal Counsel, to confirm that statement. Mr. Attebery, Legal Counsel, stated that it is correct and as a result of LAFCo's authority to determine whether an annexation is appropriate the Commission should take all the steps outlined by Mr. Glaser. He also stated that it is the Executive Officer's obligation to provide the Commission with his independent review.

Commissioner Patti said that LAFCo is not taking away what Tracy has received in the past but the City should follow protocol as with all other Cities.

Bob Bentz addressed the Commission.

Chairman Johnson closed Public Comments.

Chairman Johnson opened Commissioner Comments.

Commissioner Kuehne commented that a lot of discussion took place on tax sharing agreements but this is not under LAFCo purview. He said that what is under LAFCo purview are municipal service reviews, orderly growth, and adequately service provision. Although Mr. Bowman pointed out that any resolution made today might degrade the ability to provide that service he is not disagreeing with that but in by the same token LAFCo must make sure there is financial resources to provide adequate services. Annexation is what LAFCo does and it encourages detachments in annexations. Commissioner Kuehne said LAFCo needs to move forward with this.

Commissioner Winn added that this issue has been going on for about 23 years and LAFCo needs to resolve it. Therefore, it is time to make a firm decision and detachment is the right one to make.

Commissioner Winn left the meeting at 11: 17 a.m.

Commissioner Villapudua agrees with other Commissioners.

The motion was made by Commissioner Villapudua, seconded by Commissioner Patti to approve Resolution No. 1402, adopting an annexation policy for the City of Tracy and Tracy Rural Fire protection District.

The motion passed by a unanimous vote of the voting members of the Commission

Chairman Johnson asked Mr. Glaser to talk about the next steps.

Mr. Glaser, Executive Officer, went over the next steps needed for the City of Tracy prior to consideration of an annexation.

Commissioner Johnson informed the City of Tracy to continue to work with LAFCo in moving forward to get the annexations done.

Commissioner Patti added that everything that we are asking to get this done is LAFCo protocol and LAFCo is not asking for anything different.

James E. Glaser, Executive Officer, said that LAFCo is willing to help to keep this moving forward consistent with LAFCo policies.

Commissioner Patti checked with Mr. Attebery, Legal Counsel, if LAFCo was following LAFCo policies. Rod Attebery, Legal Counsel, stated yes, that Mr. Glaser is following C-K-H policies as well as the Commission policies.

SUBJECT: CITY OF STOCKTON OUT-OF-AGENCY SERVICE REQUESTS

Recommendation

It is recommended that the Commission approve the request from the City of Stockton to provide out-of-agency sewer service under the Government Code §56133 to property located at 530 S. Hinkley Avenue, Stockton.

Background

Government Code Section §56133 states that the Commission may authorize a city or special district to provide new or extended services outside its jurisdictional boundaries but within its sphere of influence in anticipation of a later change of organization and that prior to providing new or extended service, the city or district must first receive approval from LAFCo. The Commission adopted a policy that conditions their approval for out-of-agency service requiring the recordation of an agreement with the landowner consenting to annexation of their property when annexation becomes feasible.

The City of Stockton submitted a request for approval to extend sanitary sewer service to a single family residences outside the city limits but within the City's sphere of influence. A vicinity map is attached showing the location of the out-of-agency request. Connection to City sewer lines are available to the property and the property owner has paid the appropriate connection fees to the City. The request for out-of-agency service is in compliance with the Government Code §56133 and Commission policies. Staff recommends approval of the attached Resolution 1404 approving out-of-agency services.

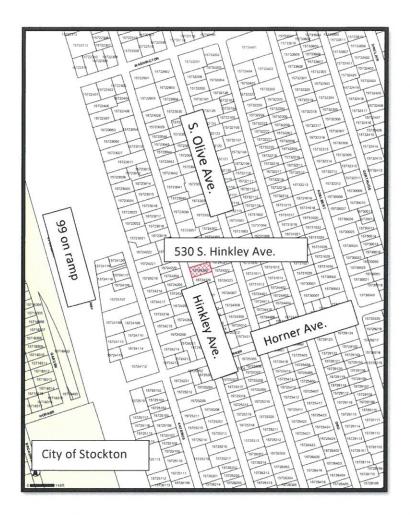

SUBJECT: Draft Municipal Service Review/Sphere of Influence Plan Workshop Bryon-Bethany Irrigation District and The West Side Irrigation District

Recommendation

It is recommended that after receiving testimony and providing comments on the Draft Municipal Service Review/Sphere of Influence Plan for Bryon-Bethany Irrigation District (BBID) and The West Side Irrigation District (TWSID) that the matter be scheduled for a public hearing on June 13, 2019.

Background

A Municipal Service Review (MSR) is a comprehensive review of an agency intended to obtain information about the agency's ability to provide services. Its purpose is to evaluate the provision of services from a comprehensive perspective and recommend actions, when necessary, to promote the efficient provision of those services. Service reviews are intended to serve as a tool to help LAFCo, the public and other agencies better understand the public services that the agency currently provides. State law requires that LAFCo update Spheres of Influence and prepare a Municipal Service Review in conjunction with that update.

The MSR is required by the Cortese-Knox-Hertzberg Act to have six categories, as defined by the San Joaquin LAFCo "Service Review Policies" December 14, 2012. Each of these categories requires a written determination. The six categories are as follows:

• Growth and Population Projections for the Affected Area

- The Location and Characteristics of any Disadvantage Unincorporated Communities within or Contiguous to the Sphere of Influence
- Present and Planned Capacity of Public Facilities and Adequacy of Public Services, Including Infrastructure Needs and Deficiencies
- Financial Ability of Agencies to Provide Services
- Status of and Opportunities for Shared Facilities
- Accountability for Community Service Needs, Including Governmental Structure and Operational Efficiencies

In determining a sphere of influence, the Commission is required to consider and make written determinations with respect to the following factors (Government Code Section 56425):

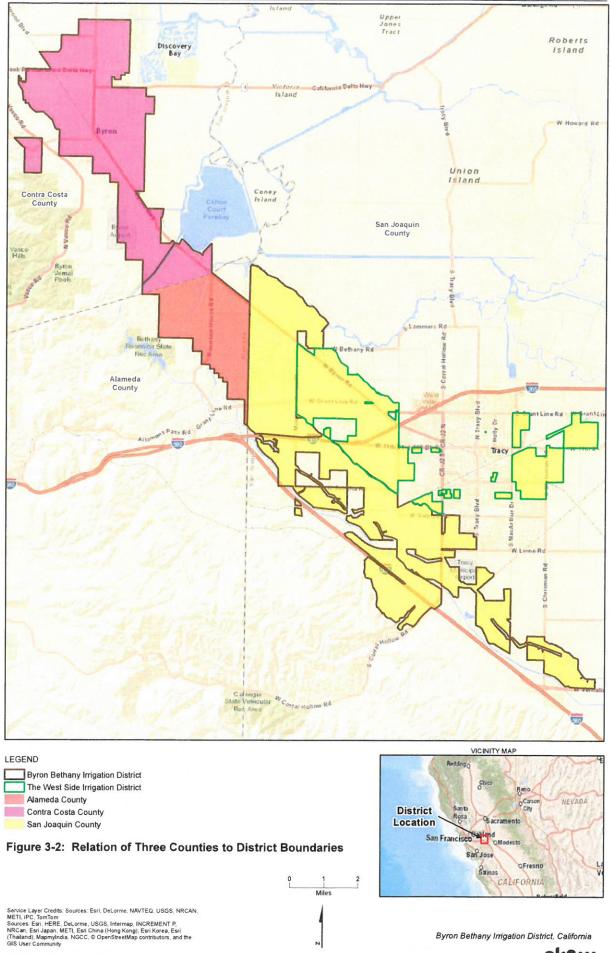
- The Present and Planned Land Uses in the Area, Including Agricultural and Open Space Lands.
- The Present and Probable Need for Public Facilities and Services in the Area.
- The Present Capacity of Public Facilities and Adequacy of Public Services that the Agency Provides or is Authorized to Provide.
- The Existence of Any Social or Economic Communities of Interest in the Area if the Commission Determines that they are Relevant to the Agency.
- The Present and Probable Need for those Public Facilities and Services within any Disadvantaged Unincorporated Communities (DUCs) within the Sphere of Influence.

Byron Bethany Irrigation District

BBID became a public district in December 1919. Originally formed as a private company, called the Byron-Bethany Irrigation Company, in 1914 it utilized long-term (pre-1914) water rights. BBID procures and supplies raw water to be used for irrigation and municipal purposes. In addition to its pre-1914 water rights, BBID also has a contract with the U.S. Bureau of Reclamation for 20,600 acre-feet (AF) for the Central Valley Service Area. The District consists of approximately 29,477 acres and is located in Alameda, Contra Costa, and San Joaquin Counties. (See Figure 3-2)

The West Side Irrigation District

TWSID was originally formed on October 12, 1915 and began making its first water deliveries four years later in 1919. TWSID provides the delivery and sale of irrigation water, agricultural drainage, storm and municipal drainage, and municipal and industrial water. The District consists of approximately 6,589 acres located in the unincorporated territory to the east and west of and within the City of Tracy. TWSID has a license from the State Water Resource Control Board to divert 27,000 AF of water from Old River. TWSID also has a contract with the U.S. Bureau of Reclamation to receive 2,500 AF from the Central Valley Project. TWSID currently functions as an independent district governed by a five-member Board of Directors.

Consolidation

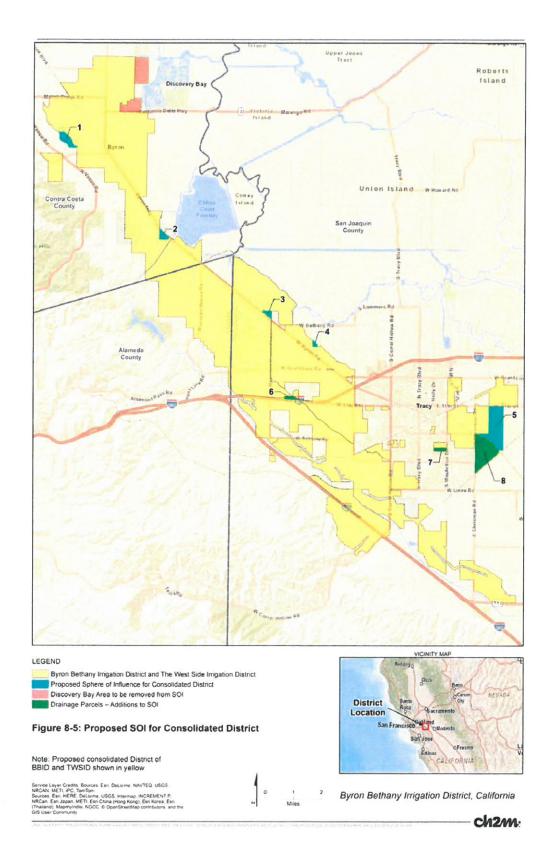
The Boards of Directors of Byron Bethany Irrigation and The West Side Irrigation District approved a concurrent resolution for the consolidation of the two Districts. The Districts propose to accomplish the consolidation by combining the territory of TWSID with the territory of BBID, and creating BBID as the single successor district. TWSID would no longer be a separate entity. The reason for the consolidation is to enhance the services provided to the territories of both BBID and TWSID. In the interim, TWSID and BBID entered into a December 2016 Management Agreement (Agreement for Services) such that BBID provides management services to TWSID. Management services covered under the 2016 Agreement include provision of a General Manager, operations, and maintenance support. TWSID retains its separate legal counsel, until the consolidation is formally approved by LAFCo. Figure 8-5 shows the proposed Sphere of Influence for the Consolidated District.

The MSR/SOI document has been transmitted to the surrounding jurisdictions and State and Federal water agencies. LAFCo has not yet received any comments. Any comments will be included in the final report.

The Commission's service review policy sets forth the procedure for public participation and public hearing. The policy requires a two-step process for the adoption of a service review: 1) a public meeting/workshop with the Commission to accept comments from the public and the Commission "prior to finalizing the document", and 2) a formal 21-day review period and public hearing. Staff will provide public notice for the June 13, 2019 meeting to meet our legal obligation for a public hearing. The Commission will be able to adopt the MSR at that meeting or may continue the matter to a future meeting. A motion is attached for Commission's consideration.

The draft report was previously transmitted at the Special April 22, 2019 meeting to the Commissioners for their early review.

Background

On February 14, 2019 the Commission approved the consolidation of Reclamation District 2038 and Reclamation District 2039 and directed the Executive Officer to conduct protest proceedings. By statute, the approval of a consolidation is subject to a protest hearing. A protest hearing was held on April 19, 2019 at 10:00 a.m. at the LAFCo Office at 509 W. Weber Avenue, Suite 420, Stockton, CA.

In accordance with Government Code Section 57075(a) the Commission shall make a determination regarding the value of the written protests filed and not withdrawn and take the appropriate action based on the results:

• If at least 25% of the number of landowners within the territory subject to the consolidation, owning at least 25% of the assessed value of land within the territory then an election would be held

No written protests were received by the close of the Protest Proceedings. Based on the final results of the protest proceeding, the appropriate action is to take is to order the consolidation of RD 2038 and RD 2039.

SUBJECT: LAFCO PRELIMINARY BUDGET FOR FISCAL YEAR 2019-2020, WORK PROGRAM, AND SCHEDULE OF FEES

Recommendation

It is recommended that the Commission, after receiving testimony and proving comments, schedule a Public Hearing on June 9, 2019 for approval of the Final Fiscal Year 2019-2020 Budget, Work Program and Schedule of Fees.

Overview

In compliance with the provisions of the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (CKH Act), the attached Preliminary Budget for Fiscal Year (FY) 2019-20 is submitted for Commission approval. The CKH Act requires the Commission to approve a preliminary budget by May 31 and a final budget by June 15th.

The Commission Budget Committee comprised of Chairman Peter Johnson and Commissioner Patti met on April 22, 2019 to review the status of the current budget year, the proposed work program, fee schedule, and to consider alternative budget options for the upcoming fiscal year. The Budget Committee's recommendation for the FY 2019-2020 budget is attached.

The proposed budget anticipates revenues in the amount of \$474,600 from the following sources: \$222,800 contribution from the County; \$222,800 contribution from the seven cities;¹ \$15,000 in from application filing fees; and \$14,000 interest revenue. The budget anticipates that the cost for staffing and operations will be approximately \$728,958 and that the Commission will transfer

¹ The County and its cities contribute one-half share of LAFCo's operational costs. The Cities share is based upon the proportionate share of the total county population living within cities. Using the January 2017 population data from the State Department of Finance, the city contributions would be as follows: Stockton-\$119,644; Tracy-\$33,866; Manteca-\$28,518; Lodi-\$23,839; Lathrop-\$8,689; Ripon-\$5,570; and Escalon-\$2,674.

\$254, 358 from its existing \$876,753 Contingency/Reserve fund to continue agency operations to the end of the fiscal year.

As directed by the Commission during last year's budget approval process the proposed County and City contributions were increased by 3%. The Commission decided that the County and City Contributions should be increased by 3% each year. The Committee also proposes that \$200,000 be set aside in the Contract for Services line item in the event that the Commission wishes to contract out for special studies, complete municipal service reviews, or other matters that require an outside consultant.

Although the proposed budget attached does not include salary changes, the Budget Committee requests that the Commission discuss the Executive Officer's salary in a Closed Session. A Final FY 2019-2020 budget will reflect any changes for approval at the June Public Hearing.

Work Program

For 2019-2020, the LAFCo Work Program will include application processing for annexations and other organizational changes and out-of-agency service requests. Municipal Service Reviews (MSRs) and Sphere of Influence (SOI) will be updated for the cities of Escalon and Lodi. LAFCo completed MSR and SOI Updates for 21 reclamation districts and may, based on Commission direction, begin work on the remaining 29 reclamation districts. MSR and SOI updates may, based on Commission direction, will be completed for County rural fire districts as well as a MSR and SOI amendment for South San Joaquin Irrigation District.

LAFCo anticipates a consolidation proposal from Byron-Bethany Irrigation District and West Side Irrigation District.

The Commission will review and update, as needed, it operational policies and procedures.

Schedule of Fees

The Budget Committee reviewed the application filing fee schedule and proposes the following adjustments:

- Increase fee from \$1,200 to \$3,000 for Amendments to a Municipal Service Review
- Clarification of the Surveyor Map Checking Fee by adding the words "whichever is higher"

The Budget Committee requested that Staff review the current fee schedule and compare our application filing fees with those of other LAFCos. A preliminary review of other fee schedules indicates a wide variety of ways to charge for services and would require more time for a thorough review. Staff will present its analysis at the final budget hearing June. There is no requirement that the fee schedule must be approved with the budget. If the Commission desires, an approval for the fee schedule can be postponed until a later date.

Accomplishments

During the current FY2018-2019, LAFCo processed 13 Out-of-Agency requests, annexed territory to Woodbridge Irrigation District and County Service Area 29, dissolved 2 inactive independent special districts and completed a consolidation. Municipal service reviews and Sphere of Influence Updates were completed for the City of Stockton, Reclamation District 2038 and 2039 and a MSR/SOI Update is pending for Byron Bethany Irrigation District and the West Side Irrigation District and the City of Tracy. In May, the Commission resolved the issue regarding the governance model for providing fire protection for the City of Tracy and Tracy Rural Fire District and adopted a policy of "detachment" of the fire district from the City. The Commission actively recruited and selected a new Public Member to serve on the Commission.

Staff will be prepared to discuss the Final Budget, Work Program and Schedule of Fees at the June 13, 2019 meeting.
